

# **Red Hat Open Demos Drawing June 2021**

## **Official Rules**

NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. VOID WHERE PROHIBITED.

ENTRY IN THIS PROMOTION CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES.

1. **Eligibility.** To be eligible to enter the Red Hat Open Demos Drawing June 2021 ("Promotion"), you must: 1) be a legal resident of the United States; 2) be of the age of majority in your jurisdiction of residence; and 3) register for and attend any of the 13 Open Demos listed below ("Participant"). 2. **Entry.** NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED. The Promotion takes place between June 1, 2021 at 11:00 a.m. EDT and June 30, 2021 at 4:00 p.m. EDT ("Promotional Period"). To enter, Participant must visit [https://red.ht/June2021\\_OpenDemo\\_Raffle](https://red.ht/June2021_OpenDemo_Raffle) during the Promotional Period and fill out all required fields on the entry form ("Entry").

**LIMIT – Participant may submit one (1) Entry for each Open Demo he/she attends.** Subsequent Entries will be disqualified. All Entries become the property of Sponsor and will not be acknowledged or returned. Only eligible Entries actually received by Sponsor within the Promotional Period will be included in the Prize Drawing. Use of automated entries or programs or entries submitted by third parties is prohibited and such entries will be disqualified. Sponsor will not be responsible for any computer related, online, telephonic, or technical malfunctions that may occur whether or not within Sponsor's control and such Entries are void. The potential winner will be notified by email on or about July 16, 2021 at the email address provided by the Participant on his/her Entry ("Prize Notification"). If a potential winner does not respond within 48 hours after the Prize Notification is sent, or if the Prize Notification is returned as undeliverable, that potential winner will be deemed to have forfeited the Prize, and Sponsor will select an alternate potential winner in his/her place at random from all remaining eligible Entries until the Prize has been awarded.
